## 3. Purpose/Statement of Need:

- **3.1 Background:** According to the Minnesota Attorney General's Office, Minnesota's maximum share 5<sup>th</sup> largest settlement over the 18-year period, approximately \$18 million. In January 2022, the St. Louis County Board Chair called for the Opioid Remediation Settlement Funds Subcommittee to be created, appointed 3 commissioners as well as the Sheriff, County Attorney and Public Health and Human Services (PHHS) Director. The Board Chair also requested a call for applicants to serve on this expert panel in which 21 community members responded, representing law enforcement, medical community, providers, harm reduction services, peer recovery organizations and families and individuals directly impacted by the opioid use crisis. The subcommittee has successfully allocated \$1.2 million in Round 1 of funding and has recommended allocating funds in an additional 2 rounds of funds. Funds allocated come from St. Louis County's Opioid Settlement Funds. The subcommittee is seeking proposals for funds to be focused specifically on upstream prevention, which can include both primary and secondary prevention, with priorities being outlined below.
- **3.2** The Opioid Remediation Subcommittee: The purpose of the Opioid Remediation Subcommittee is to make recommendations to the County Board on the distribution of St. Louis County's opioid settlement funds. The purpose of the funding is intended to support positive long-term impacts in the areas of prevention and harm reduction. Through an intersection across broad stakeholder input, subcommittee member input, County Board input and best practices, the Opioid

Remediation Subcommittee determined upstream prevention to be the next recommended priority funding area

#### **3.3** Scope of Service - Priorities

The priorities for this RFP are based off the community assessment the subcommittee completed and will focus on upstream prevention programs. The priorities include:

- 1) Youth education and programming that focuses on developmental assets education to support healthy youth development. Examples include early childhood prevention education, implementing evidence-based school curriculums, or risk and protective factors education
- 2) **Broad prevention focused community-based education** that supports the wellbeing of communities, families, and youth
- 3) Adult wellbeing education and skills that equip parents, educators, and community leaders to support their own wellbeing so they can model positive behaviors and create a stable foundation for youth to thrive.

To directly address these issues, the Opioid Remediation Subcommittee is inviting communitybased organizations within St. Louis County and internal St. Louis County departments to submit proposals for a multi-year funding opportunity that addresses one or more of the above priorities within St. Louis County. These projects or initiatives can build on existing programs but need to demonstrate how they will specifically address one of the identified priorities. These funds cannot be used to supplant current funding that an organization has already received.

#### 3.4 Services/Resources to be Developed:

The Opioid Remediation Subcommittee is requesting proposals focused on upstream prevention with the goal to build resilience, decrease risk factors, and build protective factors that positively impacts the future of our youth, families, and communities across St. Louis County. Proposals do not need to serve all of St. Louis County but need to (1) clearly identify why the organization is positioned to successfully implement the proposed project for a specific community or geographic area; (2) provide a detailed background of the evidence-based or practice-informed program or practice being proposed. If awarded, please note that any proposed sub-contracting (including trainers, presenters, independent contractors, etc.) to be paid with opioid settlement dollars must receive prior approval from the designated SLC representative.

#### 3.5 Client population to be served:

Project proposal must (1) be implemented within St. Louis County and serve residents within St. Louis County; (2) clearly demonstrate how the project will support and serve individuals affected by one or more of the priorities described above in section 3.2.

# 9. Insurance:

**If your proposal is selected for contract, the following insurance must be maintained for the term of the contract:** A Certificate of Insurance for each policy must be on file with the St. Louis County Public Health and Human Service Department Contract Services. Each certificate must include a 10-day notice of cancellation non-renewal, or material change to all named and additional insureds.

### 9.1 General Liability Insurance

- 9.1.1 \$500,000 when the claim is one for death by wrongful act or omission and \$500,000 to any claimant in any other case.
- 9.1.2 \$1,500,000 for any number of claims arising out of a single occurrence.
- 9.1.3 No less than \$2,000,000 Aggregate coverage.
- 9.2 Policy shall include at least premises, operations, completed operations, independent contractors and subcontractors, and contractual liability and environmental liability.
- 9.3 St. Louis County shall be named as an Additional Insured on a primary and non- contributory basis.
- 9.4 Business Automobile Liability Insurance
  - 9.4.1 \$500,000 for claims for wrongful death and each claimant.
  - 9.4.2 \$1,500,000 each occurrence.
  - 9.4.3 No less than \$2,000,000 aggregate.
  - 9.4.4 Must cover owned, non-owned and hired vehicles.
- 9.5 Workers' Compensation

Per statutory requirements, Certificate of Compliance must be executed and filed with St. Louis County.

- 9.6 Professional Liability Insurance For Licensed Professionals
  - 9.6.1 Provider shall maintain at its sole expense a valid policy of insurance covering professional liability, arising from the acts or omissions of Provider, its agent and employees in the amount of not less than \$500,000 per claim and \$2,000,000 annual aggregate. This provision applies only in situations where Provider's staff or volunteers are performing licensed professional services under this Agreement.

## 9.7 <u>Relevant Certifications or Licenses:</u>

Any provider/vendor contracting with the St. Louis County Board of Commissioners is expected to comply with the following requirements:

# 10. Selection:

All responses will be reviewed by St. Louis County Public Health and Human Services Department along with members from the Opioid Remediation Settlement Funds Committee. Prior to making the final selection, interviews may be scheduled with agency staff and committee volunteers to determine potential fit as a provider of these services. Once proposed projects are selected, recommendations to

enter into agreement(s) will be submitted to the County Board of Commissioners for their approval. Once a resolution of Board approval is obtained, contracts can be drafted and executed.

## 10.1 Summary of Scoring Matrix Criteria

Below are the criteria that will be used to determine scoring for proposals submitted:

- Proposal clearly addresses one or more of the committee's priorities below:
  - 1. Youth education and programming that focuses on developmental assets education to support healthy youth development. Examples include early childhood prevention education, implementing evidence-based school curriculums, or risk and protective factors education
  - 2. **Broad prevention focused community-based education** that supports the wellbeing of communities, families, and youth.
  - 3. Adult wellbeing education and skills that equip parents, educators, and community leaders to support their own wellbeing so they can model positive behaviors and create a stable foundation for youth to thrive.
- Proposal provides detailed description of the workplan, including timeline of services, training, implementation, impact evaluation efforts, and preliminary budget.
- The proposal demonstrates:
  - 1. Serving St. Louis County, either the entire county or a specific region of the county
  - 2. Proposal takes into consideration the communities, including racial communities and ethnic communities, most at-risk and/or impacted by Opioid Use Disorder (OUD).
  - 3. Innovation is apparent. Activities / strategies are creative and unique. Promising practice or evidence-informed approaches focused on one of the three priorities outlined above.
- Proposal demonstrates methods to evaluate and measure the effectiveness and impact of the project through the outlined proposal timeline; includes anticipated short-term and long-term impact; includes an explanation of impacts.
- Overall, the proposal is clear and logical.

# 11. Insurance:

**If your proposal is selected for contract, the following insurance must be maintained for the term of the contract:** A Certificate of Insurance for each policy must be on file with the St. Louis County Public Health and Human Service Department Contract Services. Each certificate must include a 10-day notice of cancellation non-renewal, or material change to all named and additional insureds.

- 11.1 General Liability Insurance
  - 11.1.1 \$500,000 when the claim is one for death by wrongful act or omission and \$500,000 to any claimant in any other case.
  - 11.1.2 \$1,500,000 for any number of claims arising out of a single occurrence.

- 11.4.3 No less than \$2,000,000 aggregate.
- 11.4.4 Must cover owned, non-owned and hired vehicles.
- 11.5 Workers' Compensation
