ST. LOUIS COUNTY HEALTH INSURANCE COMMITTEE

The St. Louis County Health Insurance Committee met on Wednesday, December 20th, 2023 at 9:00 a.m. via Webex. The meeting was called to order by Jim Gottschald, Committee Co-Chair.

The October minutes were approved by consensus with no requested changes.



OLD BUSINESS

- 1. The first item from the agenda under Old Business was *Blue Care Advisor (BCA) Sweepstakes (0:3:00)*. Beth Menor reported that participants can use points to buy chances at \$50-\$250 gift cards given away each quarter. These sweepstakes will help keep members engaged, especially if they earn the maximum 2400 points before the year is over.
- 2. The next item from the agenda under Old Business was an *Update on Medicare Supplement Plans (0:9:45)*. Beth Menor provided an overview of the changes to the retiree Medicare plans in 2024 which included: dental coverage, \$35 insulin copays, prescription drug cap of \$8,000/year, fewer routine eye exams and post-inpatient meal deliveries, additional dietary restriction categories and premium rate changes.
- 3. The next item from the agenda under Old Business was Hearing Aid Medical Policy (0:15:30). Beth Menor reported that manufacturers assign all models to one of two categories: standard or deluxe. Members will have standard models covered or they will get credit towards a deluxe model so members pay the difference in cost between the two models. Either model will have the same cost-sharing as other durable medical equipment (DME), namely, deductible and coinsurance. There is no specific recommended vendor but competing DMEs can be compared in the Blue Care Advisor app.
- 4. The next item from the agenda under Old Business was the *Travel Benefit Program* (0:25:00). Beth Menor began with two follow-up requests on the topic carried over from the December meeting. She reported that BCBSM was not able to provide the data requested, namely the miles traveled for care by members. Neither did they have the capability to report this data by individual member nor in aggregate. They did offer a provider utilization report. The second follow-up was regarding ancillary insurance products that offer travel benefits. Ms. Menor listed Critical Illness, Accident and Hospitalization products that either include specific travel benefits or a cash lump sum payment that could be used to cover travel expenses. Some of the products contained pre-existing exclusions. One local vendor offered no minimum participation thresholds. Discussion ensued with no consensus on an action but requests for a presentation on the ancillary product or products at the February meeting.

NEW BUSINESS

5. The first item from the agenda under New Business was *Hinge Health's (HH) Impact on Opioid Use (1:36:00)*. Beth Menor shared that our virtual physical therapy vendor, Hinge Health, issued a recent study and the results showed that 42% fewer participants initiated opioids and 25% fewer participants had opioid prescriptions as compared to traditional physical therapy patients. She also shared one of our own participant's feedback on the program:

I went on the Hinge Health therapy program in April. I have experienced a great deal of pain in both my knees. One hashad a replacement surgery but was still causing pain and stiffness and a loss of range of motion.

As of today [11/17/23], after completing all 40 levels my pain in the non-replacement knee is almost non-existent. At this point I would not consider a replacement surgery for that knee.

In the replacement knee I have been able to dramatically increase my range of motion and reduced the overall stiffness of the joint.

Also, during the process, it has encouraged me to increase my health overall. I have lost 30 pounds since starting the program. Some of the benefits I am now experiencing is an increase in many activities. I no longer avoid using stairs. I feel better overall than I have felt in several years Thanks for the benefit.

- 6. The next item from the agenda under New Business was **Review of Current Year's Goals (1:40:30).** Jim Gottschald recapped the Committee's progress on the following 2023 goals:
 - Study transitioning dependent dental coverage from fully-insured to self-insured
 - The employee and dependent plan will merge on 1/1/25
 - Fifteen employees dropped coverage and 105 added dental coverage
 - Educate & engage members to be proactive in their health & healthcare
 - 802 employees attended wellness classes in 2023

OTHER BUSINESS

- 8. The first item from the agenda under Other Business was an update from Jim Gottschald on the Public Employer Association & Coalition of Healthplans or PEACH group's activities around exploring hospital cost transparency. He reported that the group met with the Council of Health Plans of MN to join a national initiative and the two groups plan to partner on legislative initiatives and provider outreach. He committed to bringing to the committee a demonstration of the Sage transparency tool.
- 9. The next item from the agenda under Other Business was a wellness program update (2:12:30). Beth Menor reported on behalf of Tiffany Kari Cizmas that 1,120 employees/family members participated in the Total Wellness program in 2023 and of them 699 submitted wellness tracking cards. These numbers are up from 1029 and 684, respectively in 2022. Jim Gottschald reported that Total Wellness program gift cards were due for delivery within the next week. Beth Menor also shared that Tiffany Kari Cizmas will be rolling out and promoting a program in 2024 called *PT First*. The program focuses on physical therapy as a preventative measure and promotes independent providers where costs can be half that of physical therapy in a traditional clinic or hospital setting.
- 10. The next item from the agenda under Other Business was the Auditor's financial Report (2:14:30). The Auditor's report projected the 2023 year-end health fund balance to be at \$20,131,796, a net gain of \$1,585,421 from the year prior. The year-end projection at the prior meeting in October was \$18,999,399. Nancy Nilsen expressed her preference to have somewhere between eighteen and twenty million in reserve and hence, expressed her delight with the projection and stated her appreciation for everybody's work on this committee.

With no further business the meeting was adjourned.
