# OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON MAY 28, 2024

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 28<sup>th</sup> day of May 2024, at 10:00 a.m., at the Northland Town Hall, Canyon, Minnesota, with the following members present: Commissioners Annie Harala, Patrick Boyle, Ashley Grimm, Paul McDonald, Keith Musolf, Mike Jugovich and Chair Keith Nelson - 7. Absent: None - 0.

Chair Nelson asked for a moment of silence to honor those men and women who serve and protect this great nation and for those individuals adversely affected by conflict or violence both here and abroad; followed by the pledge of allegiance.

Northland Township Clerk Bobbi Pirkola welcomed the Board to Northland Township.

Commissioner McDonald, supported by Commissioner Harala, moved to approve the consent agenda. The motion passed; seven yeas, zero nays.

Commissioner Harala, supported by Commissioner Grimm, moved that the St. Louis County Board authorizes the appropriate County officials to enter into a Professional Services Agreement with Johnson Wilson Constructors of Duluth, MN, for Construction Manager at Risk preconstruction services at a cost not to exceed \$30,000. Deputy Administrator Brian Fritsinger said that the Property Management Department uses a BFA system to rank and score facilities with 0% being the best and 60% being the worst. The department's goal is to maintain facilities at a rating of 20%; the Depot is currently rated at 41%. Deputy Administrator Fritsinger noted that inflation has increased project cost estimates over the last 7-8 years. In response to Chair Nelson, Property Management Director Jerry Hall said most of the facilities that they take care of are within the threshold. Commissioner Boyle commented that there is a 4-5 year timeframe to get the building ready for the Northern Lights Express (NLX) project. After further discussion, the motion passed; seven yeas, zero nays. Resolution No. 24-281.

Commissioner McDonald, supported by Commissioner Musolf, moved that the St. Louis County Board hereby approves the continued expenditure of American Rescue Plan Act (ARPA) funds through contract amendments with listed schools and Districts extending the time frame of County ARPA funds through July 31, 2026, with additional county contributions designated, totaling 70% of the cost of ongoing mentors in 2024-25 school year and 40% of the cost of ongoing mentors in the 2025-26 school year; that \$78,673.04 will be paid to support the coordination of the program through July 31, 2026; that the school districts may adjust their budgets within each other as long as it does not exceed the grand total; and further, that the amount authorized in Board Resolution No. 21-427 and Board Resolution No. 22-444 may be moved between agencies so that remaining funds offset these contract amendments. The motion passed; seven yeas, zero nays. Resolution No. 24-282.

Commissioner Harala, supported by Commissioner Boyle, moved to consider a resolution to establish a public hearing to consider the issuance of an Off-Sale Intoxicating Liquor License to The Outpost, LLC dba The Outpost, Gnesen Township; the item had not been to Committee of the Whole. The motion passed; seven yeas, zero nays.

Commissioner Musolf, supported by Commissioner Jugovich, moved that the St. Louis County

Board establish a public hearing on Tuesday, June 11, 2024, at 10:00 a.m., at the County Courthouse, County Board Room, 100 N. 5th Avenue West, Duluth, MN, regarding the application for an Off-Sale Intoxicating Liquor License for The Outpost LLC dba The Outpost. ## BY COMMISSIONER McDONALD:

RESOLVED, That the official proceedings of the St. Louis County Board of Commissioners for the meeting of May 14, 2024, are hereby approved.

WHEREAS, The St. Louis County Public Works Department plans to reconstruct a short segment of County State Aid Highway (CSAH) 44 and to replace the existing bridge (County Bridge 382, State Bridge 7222) spanning the Cloquet River in Ault Township, further identified as County Project CP 0044-726786; and

WHEREAS, These improvements consist of replacing the existing bridge with a new bridge at the same location and reconstructing the roadway as determined necessary to provide for the safety and convenience of the public; and

WHEREAS, In addition to the existing highway right-of-way, certain lands are required for this construction, together with temporary construction easements.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board of Commissioners authorizes the Public Works Director, or his designee, to proceed with the acquisition of the necessary lands and temporary easements for this project and to execute, on behalf of the county, any easement documents as may become necessary. Right-of-way acquisition is payable from Fund 200, Agency 203001.

RESOLVED FURTHER, That pursuant to Minn. Stat. § 282.04, Subd. 4, the St. Louis

County Board authorizes the County Auditor to grant highway easements across the tax forfeited lands necessary for the project.

RESOLVED FURTHER, That the Minnesota Department of Natural Resources is requested to grant the highway easements necessary for this project on state owned property located in parts of Government Lots 4, 8 and 11 in Section 10, Township 55 North, Range 12 West in Ault Township.

### BY COMMISSIONER HARALA:

WHEREAS, On November 15, 2022, the St. Louis County Board adopted Resolution No. 22-589 authorizing a service agreement with Architecture Advantage, LLC of Duluth, MN, in the amount of \$599,875 for the planning, design, preparation of construction bid documents, project administration, project commissioning and close out for the Depot's mechanical, electrical and plumbing infrastructure improvement project; and

WHEREAS, Upon completion of Phase I (predesign) of the project, it was determined that the total project cost would be closer to \$16 million and involved a higher complexity of design work; and

WHEREAS, Costs for Phase II and Phase III increased due to the higher complexity of design work; and

WHEREAS, On September 12, 2023, the St. Louis County Board adopted Resolution No. 23-467 amending the agreement with Architecture Advantage to reflect increased pricing from \$559,875 to \$884,400; and

WHEREAS, The Construction Manager at Risk (CMR) is an integral part of the project's Integrated Design Process in the role as construction professionals in which the owner, the architect, and the CMR create a cohesive project design and delivery team and the selection committee chose Johnson Wilson Constructors of Duluth, MN, as the most qualified and competitively priced firm.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes the appropriate County officials to enter into a Professional Services Agreement with Johnson Wilson Constructors of Duluth, MN, for Construction Manager at Risk preconstruction services at a cost not to exceed \$30,000, payable from Fund 400, Agency 400024 with funds transferred from Fund 403, Agency 403001.

## BY COMMISSIONER McDONALD:

WHEREAS, School Reengagement efforts following the COVID-19 pandemic were categorically eligible investments and the County Board supported an initial investment of \$5,183,159 in 2021 via Resolution No. 21-427 and an amended increase of \$221,398 in 2022 via Resolution No. 22-444, and an amended increase of 1,468,000 via Resolution No. 23-565, for a total of \$6,872,557; and

WHEREAS, An additional \$578,403.76 is requested to fund the county share of year 4 and year 5; and

WHEREAS, Each school district budget's may change during year 4 and year 5 so the funds may be reallocated to each of the school districts depending on actual expenditures; and

WHEREAS, Significant student engagement was reported after year 2, with sustained school interest in continuing the program and noted impacts of a 72% decrease in student absences and a 73% decrease in suspensions across the 34 schools participating in the program; and

WHEREAS, Funds are expected to remain within the existing contracts due to staff vacancies; and

WHEREAS, The St. Louis County Board's Revised American Rescue Plan Act (ARPA) framework adopted October 23, 2023, via Resolution No. 23-565, included authorization for the program to continue an additional 2 school years with a school cost-share utilizing remaining funds in the COVID Response & Recovery Category; and

WHEREAS, Following Departmental outreach, the following schools responded with interest in program continuation and commitment to the school cost-share as proposed:

Commissioner Boyle noted that this is Deputy Administrator Brian Fritzinger is retiring at the end of the month and today is his last Board meeting. Commissioner Boyle commended Deputy Administrator Fritsinger for his leadership and work during the pandemic. Commissioner Boyle discussed an incident he experienced in the Boundary Waters over the Memorial Day weekend in which winds shifted and blew him of course; he and his daughter ended up staying at a camp for 8-9 hours until the winds tapered off.

Chair Nelson commented that St. Louis County is rock solid from top to bottom and professionalism starts at the Board level. Chair Nelson said his comments a few weeks ago regarding the need for the federal government to reimburse counties for Boundary Waters rescues does not change his commitment to county response; it is strictly bringing attention to the cost impacts of rescue operations in the area.

Commissioner Jugovich commented that the Board pushes County Administration hard and he would like to see both Deputy Administrator positions filled.

Commissioner Harala wished Deputy Administrator Fritsinger well and said "May your skates be sharper than your pencils and may your paper turn into fishing lures."

At 10:29 a.m., May 28, 2024, Commissioner Jugovich, supported by Commissioner Harala, moved to adjourn the meeting. The motion passed; seven yeas, zero nays.
